QUORUM AND CALL TO ORDER

Welcome Wilson, Jr., Chairman of the Board (the "Chairman"), called the meeting to order at 9:11 a.m. Based on the number of directors in attendance at the meeting, it was determined that a quorum was present and that the meeting could proceed.

She informed the Board that they are working diligently to implement the new financial software system with more comprehensive reporting, restructuring of account coding, assumption of RTAF financials, and project division within the Alamo Plan.

As the next order of business, the Chairman reported that James (Jim) Dannenbaum has tenured his resignation from the Board of Corporation. Jim was a dedicated board member from day one and we thank him for his service. Upon motion duly made by Will Hurd and seconded by Hope Andrade, the Board unanimously approved Mr. Dannenbaum's resignation.
